WHEREAS, The Lumbee Tribe of North Carolina, is a recognize Indian Tribe of the State of North Carolina subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The funding of \$8,000 of the unrestricted budget will be earmarked from line item 6300-Legal for the purpose of legal counsel for the Tribal Council of the Lumbee Tribe of North Carolina.

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina votes to approve the earmarking of \$8,000 for legal counsel.
