WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, Article X of the Tribal Constitution establishes an independent Tribal Elections Board ("Elections Board") and the method in which the Elections Board shall be seated; and

WHEREAS, The Tribal Council created an ordinance defining "ELECTION BOARD DISTRICTS."; and

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby appoint Mr. Kenny Berry as an alternate to the Tribal Elections Board to represent Tribal Council Districts 1, 2 and 12.
