WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribe promotes the educational, cultural, social and economic well-being of the Lumbee people, and;

WHEREAS, The Lumbee Tribe recognizes the cultural and economic importance of full federal recognition to the Lumbee people and the entire region, and;

WHERAS, the Lumbee Tribes seeks to educate and advise all tribal and communities members on the Implications of full federal recognition;

THEREFORE, the Tribal Council of the Lumbee Tribe, in accordance with completing the mission of advocating for the well-being of all Lumbee people, issues a call to all Lumbee professionals who are knowledgeable of tribal federal recognition and its Implications;

THEREFORE, the Federal Recognition Committee, Lumbee Tribal Council, and volunteering Lumbee professionals will work together to create a program that with go to each Lumbee community, advise and educate on the Implications of federal recognition;

THEREFORE, be it resolved, the Tribal Council Lumbee Tribe of North Carolina does hereby call all Lumbee professionals to assist in the creation and implementation of a program that will create a greater awareness and understanding of the Implications of full federal recognition to the Lumbee people.
