"CONTINUING RESOLUTION"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribal Council has budget oversight power, and;

WHEREAS, The Lumbee Tribal Council has the power to enact legislation to appropriate funds for operation of the tribal government, and;

WHEREAS, The fiscal year of operation of the Lumbee Tribe of North Carolina is October 1, thru September 30, and;

WHEREAS, The Annual Tribal Budget enacted by the Tribal Council will not be effective and binding until signed by the Tribal Speaker and posted for thirty (30) calendar days, and;

THEREFORE, Be it Resolved, the Tribal Council of the Lumbee Tribe of North Carolina votes to approve this "Continuing Resolution", of the FY 2019-2020 Budget with the following provisions:

- 1. Effective October 1, 2020 all expenditures incurred will be attributed to the FY 2020-2021 budget when implemented.
- 2. This Resolution is effective October 1, 2020 thru December 31, 2020.
