"LUMBEE TRIBE HOLDINGS, INC REORGANIZATION"

WHEREAS, the Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, the Lumbee Tribal Council has budget oversight power, and;

WHEREAS, the Lumbee Tribal Council has the power to enact legislation to appropriate funds for operation of the tribal government, and;

WHEREAS, the Lumbee Tribe of North Carolina approved the establishment of a for profit Tribally Owned Company, and

WHEREAS, the entity entitled Lumbee Tribe Holdings, INC is that company of which the Lumbee Tribe of North Carolina owns one hundred per cent of the stock, and

WHEREAS, the corporation was originally organized with a five (5) member Board of Directors with the Bylaws stating in Article IX Section 4. Amendments. "No bylaw adopted, amended, or repealed by the shareholders shall be readopted, amended, or repealed by the Board of Directors, unless the articles of incorporation or a bylaw adopted by the shareholders authorizes the Board of Directors to adopt, amend, or repeal that particular bylaw or the bylaws generally", and

THEREFORE, be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the amendment of the bylaws of Lumbee Tribe Holdings, Inc. The bylaws will state the change to the Board of Directors of Lumbee Tribe Holdings, INC to include five (5) members. The board will contain the following members:

- 1. Chairman of the Lumbee Tribe of NC.
- The Chair of the Tribal Council Finance Committee.
- The Vice-Chair of the Tribal Council Finance Committee.
- 4. The Chair of the Tribal Council Economic Committee.
- 5. The Vice-Chair of the Tribal Council Economic Committee.

In the event that any of the above listed Board of Directors is unable to serve for any reason the vacancy created shall be filled by a designee appointed by the current holder of that position. The appointee for the Tribal Council must be a current council member.
