WHEREAS, The Constitution Committee of the Tribal Council of the Lumbee Tribe of North Carolina has renominated Furnie Lambert, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support and agree on the nomination of Furnie Lambert to the North Carolina Commission of Indian Affairs.

THEREFORE, Be it further resolved, Furnie Lambert will serve a 3 year term on the North Carolina Commission of Indian Affairs.
