WHEREAS, Our organization has received a letter of agreement from the Boys & Girls Clubs of America dated February 5, 2021 for grant number FOUR WINDS BOYS AND GIRLS CLUB OJJDP 2020-48603, a federally funded grant in the amount of \$20,000 to be used for OJJDP 2020 Mentoring in Native American Clubs, and;
