WHEREAS, Tribal Members or those seeking Tribal Membership are entitled to due process when adverse decisions are made with regards to services and enrollment; and

WHEREAS, The Tribal Council created an ordinance establishing an "ADMINISTRATIVE COURT."; and

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby appoint Mr. Christopher Locklear to the Administrative Court to represent Tribal Council Districts 4, 10, 11 and 13.
