“AMERICAN INDIAN WOMEN MINDFULLY BUILDING RESISTANCE TO ENVIRONMENTAL ADVERSITIES THROUGH HEALING EXERCISES (AIM TO BREATHE)”

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, The Tribal Council implements a Health Committee to oversee the health and well-being of the Lumbee people, and to address all health disparities of tribal members, and;

WHEREAS, The Lumbee Tribe of North Carolina offers this resolution of support to address two topics outlined by the Institute for Environmental Health Solutions (IEHS) SEED fund RFA: (1) the molecular studies of health resiliency in vulnerable groups affected by health disparities, and (2) behavioral modification and promotion of psychosocial and behavioral well-being of individuals affected by health disparities.

WHEREAS, Preliminary evidence generated by the proposed project would provide critical information on the acceptability and feasibility of mindfulness among American Indian women, and support the next step of conducting a randomized waitlist-controlled trial to determine the effects of the adapted mindfulness-based intervention for cardiovascular risk reduction on psychological, physiological, and biological outcomes in American Indian women.

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support “American Indian Women Mindfully Building Resistance to Environmental Adversities Through Healing Exercises (Aim to Breathe)”.
