WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribal Council in conjunction with the Lumbee Tribe Finance Office is responsible for the oversight, and management of tribal funds, and;

WHEREAS, The Tribal Rolls have been closed since October 9, 2020 and Pursuant to CLLO-2010-0121-01 "AN ACT TO PROVIDE TRIBAL ENROLLMENT", Tribal Chairman, Harvey Godwin has recommended the reopening of Tribal Rolls on March 23, 2021 upon approval by the Tribal Council of the Lumbee Tribe of North Carolina and:

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina hereby reopens the Lumbee Tribal Rolls to accept new members effective April 15, 2021.
