WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, Julian Thomas Pierce was a distinguished member of the Lumbee Tribe, who fought for fair and equal treatment for the Lumbee and all people and;

WHEREAS, Julian Thomas Pierce led efforts to secure full federal recognition for the Lumbee up until his death on March 26, 1988, and;

WHEREAS, The Lumbee Tribal Council recognizes the efforts and sacrifices of Julian Thomas Pierce to secure justice and freedom for the Lumbee people;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina hereby supports the naming of federal legislation to extend full federal recognition to the Lumbee people the Julian Thomas Pierce Memorial Lumbee Recognition Act of 2021 in honor of Julian Thomas Pierce, a true hero to the Lumbee people.
