"Establishment of the Lumbee Tribal Constitution Reform Committee"

WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, The Lumbee Tribal Constitution formally adopted November 7, 2000 serves as the governing document of the Lumbee People; and

WHEREAS, The Lumbee Tribal Council has expounded the Tribal Constitution through ordinances, but to date the Tribal Constitution has but a single Amendment dated November 16, 2001; and

WHEREAS, The Lumbee Tribal Constitution and Ordinance Committee voted on June 3, 2021 to establish a committee to assist in constitutional reform in order to update the governing document to better reflect the ever changing dynamic of Lumbee Society; and

THEREFORE, Be it enacted the Lumbee Tribal Council does hereby establish the Lumbee Tribal Constitution Reform Committee to work in conjunction with Tribal Council Constitution and Ordinance Committee to develop the process and amendments whereby to secure constitutional reform; and

THEREFORE, Be it further enacted all formal proceedings of the Lumbee Tribal Constitution Reform Committee shall be open to the Lumbee Tribal Membership and this ordinance shall be cited as "THE ESTABLISHMENT OF THE LUMBEE TRIBAL CONSTITUTION REFORM COMMITTEE".

SEC1: IN THE EVENT ANY PHRASE, PART, PROVISION, PARAGRAPH, SECTION OR SUBSECTION OF THIS ORDINANCE, IS FOUND, BY THE COURT OF COMPETENT JURISDICTION, TO VIOLATE THE TRIBAL CONSTITUTION, LAWS OR ORDINANCES OF THE LTNC, SUCH PHRASE, PART, PROVISION, PARAGRAPH, SECTION OR SUBSECTION SHALL BE CONSIDERED TO STAND ALONE AND THE ENTIRETY OF THE BALANCE TO REMAIN IN FULL BINDING AUTHORITY, FORCE AND EFFECT.
