## “ELECTION BOARD ALTERNATE APPOINTMENT FOR DISTRICTS 6, 8 AND 9”

**WHEREAS**, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;


**WHEREAS**, Article X of the Tribal Constitution establishes an independent Tribal Elections Board (“Elections Board”) and the method in which the Elections Board shall be seated; and

**WHEREAS**, The Tribal Council created an ordinance defining “**ELECTION BOARD DISTRICTS.**”; and

**THEREFORE**, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby appoint Mr. Tommy Cox as an alternate to the Tribal Elections Board to represent Tribal Council Districts 6, 8 and 9.
