WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;


WHEREAS, Tribal members or those seeking tribal membership are entitled to due process when adverse decisions are made with regard to services and enrollment; and

WHEREAS, The Tribal Council created an ordinance establishing an “ADMINISTRATIVE COURT.”; and


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby appoint Ms. Ima Jean Oxendine to the Administrative Court to represent Tribal Council Districts 1 and 7.
