WHEREAS: All research tools, (paper surveys or collection of bodily fluids) collected from the Lumbee membership used in this project must be pre-approved by the Lumbee Tribe Administration, Council's Health Committee and Lumbee Health Board.

WHEREAS: all data, reports and publications collected and created by the project will be monitored, reviewed and shared with the Lumbee Tribe of NC.

WHEREAS: All publications regarding this grant findings will be approved by the Lumbee Tribe of NC Administration, Council Health Committee and Lumbee Health Board before publication.
