WHEREAS, Article VII, Section 1 of the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council implements a Health Committee to oversee the health and well-being of the Lumbee people, and to address all health disparities of tribal members, and;

WHEREAS, The Lumbee Tribe of North Carolina offers this resolution of support for Researchers at the U.S. EPA and the University of North Carolina to solicit members of the Lumbee Tribe to participate in a focus group discussion, this fall (2021), to understand how flooding and hurricanes affect the Lumbee Tribal community. Eligibility for this study will be based upon age (>18 years of Age), residency in Robeson County, NC, and having experienced home and/or property damage from Hurricane Matthew (2016) or Florence (2018), and;

WHEREAS, The goal of this research study is to identify community impacts to flooding. The projected use of this data is to create a visual data tool, perhaps a Story Map, for the community to plan, prepare for, and respond to future hurricane and flooding events, and;

WHEREAS, All persons involved with the project agree to receive prior approval before any written report is disseminated to the public or research journal. And all data will be shared with the Lumbee Tribe to be used in future grant writing. At the conclusion of the study the researcher will return and report the findings, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support "Flooding and Other Disasters: Risk and Resilience in Rural North Carolina".
