## “REOPENING OF TRIBAL ROLLS”

**WHEREAS**, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

**WHEREAS**, The Lumbee Tribal Council in conjunction with the Lumbee Tribe Finance Office is responsible for the oversight, and management of tribal funds, and;

**WHEREAS**, The Tribal Rolls have been closed since December 21, 2017 and Pursuant to **CLLO-2010-0121-01** “AN ACT TO PROVIDE TRIBAL ENROLLMENT”, Tribal Chairman, Harvey Godwin has recommended the reopening of Tribal Rolls on June 11, 2019 upon approval by the Tribal Council of the Lumbee Tribe of North Carolina and;

**THEREFORE**, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina hereby reopens the Lumbee Tribal Rolls to accept new members effective June 21, 2019.


