## REQUEST FOR A "PLAN OF ACTION" FROM THE LUMBEE TRIBE'S EXECUTIVE BRANCH ADDRESSING THE ATLANTIC COAST PIPELINE

**WHEREAS**, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers of self-governance); and,

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council") and,

**WHEREAS**, the Lumbee Tribe is charged with protecting the health and well-being of its Tribal membership;

**THEREFORE**, be it resolved that the Lumbee Tribal Chairman and the Executive Branch develop a Plan of Action including a timeframe to address the impact and issues of the Atlantic Coast Pipeline (ACP) on tribal communities. This plan of Action will be shared with the Tribal Council Officers' Committee and Health Committee no later than September 20<sup>th</sup>, 2018.
