"SAFETY IMPROVEMENTS FOR DEEP BRANCH ROAD"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina does care for the welfare, health, and safety of its tribal members. Statistics show that for the past five years, Robeson County boasts the worst crash rating in all of North Carolina and in particular the portion of Deep Branch Road located between Hwy 1003 (Chicken Road) and Preston Road is a heavily populated and dangerous section of public highway. This road leads Robeson County and the State of North Carolina in fatalities and:

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina strongly recommends that the North Carolina Department of Transportation reduce the speed limit to 45 on the previously named section of road, widen the road shoulders, place caution lights in the school zones for Purnell Swett High School and Pembroke Middle School, and improve turning lanes in the school zones. and;

THEREFORE, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby agree to support the aforementioned road improvements on Deep Branch Road to better ensure the welfare, health, and safety of its tribal members.
