WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government, and;

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council, and;

WHEREAS, The Lumbee people traditionally were an agrarian society and sustained themselves through agriculture, and;

WHEREAS, The Lumbee Tribe understands the importance of promoting and supporting Native agriculture and its sovereignty to aid in the sustainability of healthy tribal communities, and:

WHEREAS, The Lumbee Tribe acknowledges the benefit of creating a Tribal Producer Directory to promote and enhance the Lumbee Tribal Government's agricultural efforts, while giving voice to our Lumbee farmers, and;

WHEREAS, The Native American Agriculture Fund (NAAF) has established a Native Producer Directory template as a means of establishing Tribal Producer directories throughput Indian Country, and:

THEREFORE, Be it enacted the Lumbee Tribal Council does hereby duly adopt the NAAF Tribal Producer Directory to duly establish the Lumbee Tribe Producer Directory, and this legislation shall be cited as "ESTABLISHMENT OF THE LUMBEE TRIBE PRODUCER DIRECTORY"
