WHEREAS, the Tribal Constitution also gives all executive power to the Tribal Chairman, and;

WHEREAS, the Lumbee Tribal Council deems the Tribal Chairman position to be of great importance to the Lumbee Tribe, requiring unwavering devotion to preserve for all time the Lumbee way of life and community, promoting the educational, cultural, social and economic well-being of the Lumbee people, and securing justice and freedom for the Lumbee people, and;

WHEREAS, the late James "Jimmy" Earnest Goins, former Tribal Chairman of the Lumbee Tribe (2004 to 2010) having served his people well, with great leadership, dignity and honor, and;

THEREFORE, be it Resolved, the Lumbee Tribal Council gives full support to a memorial at Structure No: C-743 on highway seventy one in Robeson County to establish forever Chairman James "Jimmy" Earnest Goins of the Lumbee Tribe of North Carolina as honorable and worthy
