Whereas, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

Whereas, The Lumbee Tribal Council has the authority and responsibility to protect and foster the identity of the Lumbee Tribal members; and

Whereas, The Lumbee Tribal Council has the authority and responsibility to protect and foster the culture, history, and heritage of the Lumbee Tribe and Lumbee tribal members; and

Whereas, the ancestors of the Lumbee tribal members have been living on or in close proximity of the dark waters of Lumbee River since time immemorial and documented as such for at least 250 years; and

Whereas, the ancestors of the Lumbee tribal members have always maintained a strong ceremonial connection, and affinity for the dark waters of the Lumbee River which has sustained our way of life since inception; and

THEREFORE, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support and embrace the use of the verbiage People of the Dark Water to accompany our tribal name The Lumbee Tribe of North Carolina any time it is used to reaffirm our traditions, heritage, culture, and geographical identity of the Lumbee Tribe of North Carolina.
