“ADMINISTRATIVE COURT RE-APPOINTMENT FOR DISTRICT 2 (2, 3 AND 14)”

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, Tribal members or those seeking tribal membership are entitled to due process when adverse decisions are made with regard to services and enrollment; and

Whereas, The Tribal Council created a ordinance establishing an “**ADMINISTRATIVE COURT.**”; and


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby re-appoint Mr. Gary Deese to the Administrative Court District 2 seat to represent Tribal Council Districts 2, 3 and 14. Mr. Gary Deese will serve a 5 year term which will expire on November 19, 2025.
