WHEREAS, Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, Tribal members or those seeking tribal membership are entitled to due process when adverse decisions are made with regard to services and enrollment; and

Whereas, The Tribal Council created a ordinance establishing an "ADMINISTRATIVE COURT."; and

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby reappoint Mr. Gary Deese to the Administrative Court District 2 seat to represent Tribal Council Districts 2, 3 and 14. Mr. Gary Deese will serve a 5 year term which will expire on November 19, 2025.
