Danielle McLean gave a presentation/update on behalf of Chairman Harvey Godwin, Jr's behalf. The update included information on the services still being provided to members while the tribal building is closed. CARES Act Activities/Tribal Services applications will be taken on June 22, 2020 for Housing Assistance to income eligible tribal members for one month of rent, mortgage, or utility assistance up to \$700. Applications for COVID Energy Assistance will start June 22, 2020. Testing as a part of the CARES ACT, LTNC will provide a drive through testing at various sites throughout the tribal territory, 2000 test have been ordered testing will begin after July 4 and will continue into August. Rent has been waived for the months of April-June for 37 stock and Elderly Rental units. Mortgage payments were deferred for tribal homeowners in April and May, July mortgage payment for homeowners will be waived. The MAT program is still providing services for members with substance abuse issues. The tribal building will remain closed while phase II is in effect. Chairman's Annual state of the Tribe Address will be held on July 3, 2020 @ noon via the tribal website and YouTube Channel.
