WHEREAS, Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina annually adopts a fiscal year budget, which is inclusive of all tribal programs, and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina does support and acknowledge Tribal Chairman Harvey Godwin, Jr's immediate designation of Ms. Tammy Maynor, Director of Governmental Affairs, as the Interim Tribal Administrator and;

**THEREFORE**, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby agree to accept Ms. Tammy Maynor as the Interim Tribal Administrator.
