#### "SUPPORT LUMBEE CANCER EDUCATION AND AWARENESS EVENT"

**WHEREAS**, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, Tribal Council has the authority and fiduciary responsibility to ensure compliance with all programs funding and allocation, and

**WHEREAS**, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and

WHEREAS, American Indians in North Carolina face a number of disparities in health conditions, including cancer. Many of these disparities are due to lack of access to health care and low levels of health literacy.

**WHEREAS**, Cancer screening has been shown to be effective in detecting cancer early and implementing treatments to enhance survival. However, many people choose not to get screened for cancer due to costs, inadequate access to screening services and fear of the procedure.

**WHEREAS**, The Comprehensive Cancer Centers of UNC, Duke and Wake Forest will implement a cancer education and awareness event for Lumbee families in Robeson and surrounding counties. The event will be held on Saturday, October 23, 2021 at the Lumbee Culture Center. Partners will include the Gibson Cancer Center, UNC Pembroke, and Pfizer Oncology.

**THEREFORE**, Be it resolved the Lumbee Tribal Council does hereby fully support this Lumbee Cancer Education and Awareness Event hosted by The Comprehensive Cancer Centers of UNC, Duke and Wake Forest.
