WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, Tribal Council has the authority and fiduciary responsibility to ensure compliance with all programs funding and allocation; and

WHEREAS, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and

WHEREAS, The Maxton Pond is deemed a landmark of historic significance to the Lumbee people and is a natural resource that, in times past, has provided a scenic haven and recreational fishing area to many; and

WHEREAS, Both Hurricanes Matthew and Florence ultimately destroyed the dams and roadways that made the Maxton Pond accessible to the public; and

WHEREAS, Ms. Rebecca Asser, an NC State Masters Graduate Student of Landscape Architecture and Environmental Planning has been provided as a Global Change Fellow by the Southeastern Climate Adaptation Science Center to assist the Lumbee Tribe of NC in environmentally friendly measures toward the restoration and revitalization of the Maxton Pond; and

WHEREAS, On March 2, 2020 the Agriculture and Natural Resources Committee unanimously approved measures to move forward with planning and design to restore the Maxton Pond to her original glory; and

THEREFORE, Be it resolved the Lumbee Tribal Council does hereby agree to support and collaborate with the Southeastern Climate Adaptation Science Center and Ms. Rebecca Asser in measures designed to revitalize and restore the Maxton Pond to her original glory.
