## “UNRESTRICTED FUNDS FOR THE LUMBEE TRIBE’S INAUGURATION”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe Of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget as deemed appropriate to maintain a balanced budget; and


**WHEREAS**, The Office of Chairman Harvey Godwin Jr are requesting temporary funding in the amount of \$7,129.96 for the Lumbee Tribal Inauguration; and

**WHEREAS**, The Funding of \$7,129.96 will be moved from “Unrestricted Revenue” GL 5106 Contingency line item; and will be reimbursed once any unrestricted funds are received; and

**THEREFORE**, Be it resolved by the Tribal Council of the Lumbee Tribe of North Carolina that the Finance Department of the Lumbee Tribe Of North Carolina is hereby authorized the release of \$7,129.96 budgeted to the Lumbee Tribes Inauguration.
