WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

**WHEREAS,** Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina created the Health and Human Services Subcommittee to promote the health and well-being of the Lumbee people, and to address health disparities among the Lumbee people, and;

**WHEREAS**, Most tribes along the Eastern and Southern Seaboard are not eligible for health care services from Indian Health Services (HIS), and;

WHEREAS, Florida State University has sought to partner with these tribes in order to gather tribal health information through the use of Behavioral Risk Factor Surveillance Systems (BRFSS) tribal surveys as to offer a robust comparison to national data from "Tribal Epidemiology Centers and other tribal BRFSS, and;

WHEREAS, The Lumbee Tribal Council is charged to protect the wellbeing of the Lumbee people, and;

**BE IT THEREFORE RESOLVED**, The Health and Human Services Committee and the 2020 Lumbee Tribal Council does hereby support "Florida State University Behavioral Risk Factor Surveillance System Survey Project".
