"REQUEST FOR RESOLUTION OF SUPPORT OF CLLR-2020-1015-01 "NATIVE AMERICAN MASCOTS"

WHEREAS, The Lumbee Tribe of North Carolina, a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

WHEREAS, The Lumbee Tribal Council has the authority and responsibility to protect and promote the educational, cultural and historical heritage of the Lumbee Tribe and Lumbee tribal members; and,

WHEREAS, The National Congress of American Indians encouraged and promoted a campaign to discourage institutions and other entities from instituting Native American images that create negative stereotypes of indigenous people; and,

WHEREAS, The Lumbee Tribe of North Carolina exhibits pride in and honor of our identity; and,

WHEREAS, The Lumbee Tribe of North Carolina fervently regards the Red Raider mascot as offensive, dehumanizing, mocking, and demeaning; and,

WHEREAS, Despite the continued petition by Native American Tribes requesting the removal of Indian mascots there still exists a lack of interest by those agencies, institutions, or individuals concerning the negative and psychological impact upon native people; and,

WHEREAS, The Lumbee Tribal Council enacted CLLR-2020-1015-01 "Native American Mascots" on October 15, 2020, which exerts opposition of any and all derogatory, offensive, and or inflammatory Native American mascots for any and all educational institutions; and,

THEREFORE, Be it resolved, the Lumbee Tribal Council does hereby respectfully request the Gaston County Board of Education to support the Lumbee Tribe of North Carolina Legislation CLLR-2020-1015-01, and thus remove the Red Raider mascot.
