WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, Tribal Council has the authority and fiduciary responsibility to ensure compliance with all programs funding and allocation, and

WHEREAS, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and

WHEREAS, Current barriers to increasing health outcomes for pregnant women, babies, and families include lack of funds for specialized technical assistance in the area of contraceptive care, maternal health and infant mortality; and

WHEREAS, Supporting patient choice in and access to contraceptives empowers women and leads to healthier pregnancies, babies, and families; and

WHEREAS, The American Indian Health Board has completed and published an extensive study on the health disparities our Native American women face before, during and after pregnancy and the infant mortality rate of our Native Americans in NC.

WHEREAS, Upstream USA, a nonprofit organization, has a program that provides training, technical assistance, and financial support to health care facilities and providers in the state of North Carolina to identify and eliminate barriers to same-day contraceptive access and to improve the effectiveness of contraceptive care; and

THEREFORE, Be it resolved the Lumbee Tribal Council does hereby fully support Upstream USA in their work to improve contraceptive care, maternal health and infant births to tribal members across the state of North Carolina.
