“Resolution To Expedite Remaining Scholarship Funds For 2020”

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina has an *Education, Cultural and Public Relations Committee*, and,

WHEREAS, This committee established the Lumbee Tribal Educational Scholarship to assist tribal members through scholarships in their efforts to assist in the finances of their education, and;


WHEREAS, The Lumbee Tribe of North Carolina has a remaining balance of \$11,000 in the scholarship fund for 2020 award year, and;

WHEREAS, The Lumbee Tribal Scholarship Committee has already identified Lumbee students who met the requirements to compete for the Lumbee Tribal Scholarship, and;


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does agree to disburse the remaining scholarship funds to the students next on the list according to scholarship criteria and who qualify.
