OUT OF TRIBAL TERRITORY VOTING DISTRICT DESIGNATION

As a member of the Lumbee Tribe, you are entitled to vote in tribal elections (adults 18+). If you live outside the tribal territory (Robeson, Scotland, Hoke, and Cumberland Counties) in NC, you must declare a voting district inside of the tribal territory to vote in tribal elections. The district you select is a permanent designation and should include the community where you or your ancestors grew up, or the community you consider "home" inside the territory.
