**WHEREAS**, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

**WHEREAS**, The Tribal Council implements a Health Committee to oversee the health and well-being of the Lumbee people, and to address all health disparities of tribal members, and;

**WHEREAS**, The Lumbee Tribe of North Carolina offers this resolution of support to partner with Best Friends Animal Society to reduce the intake of adoptable, treatable pets in Robeson County Animal Shelters. The Lumbee Tribe of NC will collaborate with Best Friends Animal Society to help them better understand what is needed in the territory to save more pets by potentially offering free spays and neuters, vaccinations, and health checks for animals in the territory, as well as the community animals roaming in the communities.

**THEREFORE**, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support “Best Friends Animal Society”.
