“ADMINISTRATIVE COURT RE-APPOINTMENT FOR DISTRICTS 5 AND 12”

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, Tribal members or those seeking tribal membership are entitled to due process when adverse decisions are made with regard to services and enrollment; and

Whereas, The Tribal Council created an ordinance establishing an “**ADMINISTRATIVE COURT**.”; and

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby re-appoint Mrs. Jo Ann Harris to the Administrative Court to represent District 5 which includes Tribal Council Districts 5 and 12. Mrs. Jo Ann Harris will serve a 5 year term which will expire on December 17, 2025.
