**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe Of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget as deemed appropriate to maintain a balanced budget; and

**WHEREAS**, The Lumbee Tribe of North Carolina has received a grant “CAMPBELL SOUP FOUNDATION” in the amount of \$25,000.00; and

**WHEREAS**, The grant will be administered as described in the budget attached; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the” CAMPBELL SOUP FOUNDATION” subject to all inclusions and provisions


