WHEREAS, The Tribal Council has the authority to approve, enact and amend the annual fiscal year budget and budget process; and,

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and,

WHEREAS, The Lumbee Tribal Budget Amendment is to be used to address the following changes (see below) ;and,

THEREFORE, The Lumbee Tribal Budget is amended as follows to the "Fiscal Year October 1, 2019 - September 30, 2020 Lumbee Tribal Budget Ordinance"; and,

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance cited as the "Fiscal Year October 1, 2019 - September 30, 2020 Lumbee Tribal Budget Ordinance" shall be subject to all inclusions and provisions.
