WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section1 of the Tribal Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council: and

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt, and amend the annual fiscal year budget and budget process; and

WHEREAS, The Tribal Council is responsible for overseeing, reviewing, and approving actual expenditures and budget variances throughout the fiscal year; and

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget as deemed appropriate to maintain a balanced budget; and

WHEREAS, The grant is to be used to provide rental assistance and supportive services to American Indian Veterans that are homeless or at risk of homeless.

THEREFORE, The grant will be designated to provide rental assistance to qualified American Indian Veterans who are homeless or at risk of homelessness.

THEREFORE, Be it resolved by the Tribal Council of the Lumbee Tribe of North Carolina the following "**Tribal HUD-VASH DEMONSTRATION PROGRAM**", in the amount awarded (which will be reported to the Tribal Council in August of 2018) for rental assistance and administrative cost be accepted and we authorize the Department of Housing to administer the grant in accordance with "**TRIBAL HUD-VASH DEMONSTRATION PROGRAM**".
