## “LUMBEE TRIBE BUDGET ADDENDUM”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized Indian Tribe of the State of North Carolina subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

**WHEREAS**, Article VII Section 1-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal year budget and budget process; and,

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and,


**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget upon the chairman's recommendation as deemed appropriate to maintain a balanced budget; and,

**WHEREAS**, The Lumbee Tribe Indian Housing Plan proposes building a Model Home in the amount of \$200,000;

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina that any previous Tribal Operating Budget nor Tribal Operating Budget FY 2021-2022 shall not include construction of a model home, funds will be used instead for constructing a home for a qualified tribal applicant, and the following ordinance shall be cited as the “**Lumbee Tribe Budget Addendum**” subject to all inclusions and provisions as stipulated by the Lumbee Tribal Council.

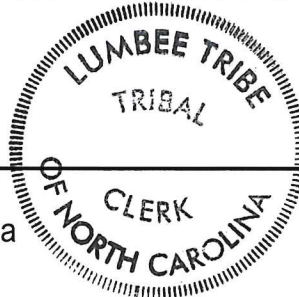
