11	Locklear if he would lead us in prayer.

13	Locklear.)

19	(The preamble to the tribal constitution
20	was read.)
21	MR. LESAUNDRI HUNT: Thank you. Before we do
22	the roll call, if you would, please put your cell
23	phones make sure they're on vibrate or on silence,
24	please and our rules are up on the board at the
25	moment Then weld like to ask that everyone please

1	remove your hat or cap. This is one of our rules
2	also. Ms. Jan Lowery will read the roll.

1	MR. LESAUNDRI HUNT: Okay. We have a motion and
2	a second. All in favor, say aye.
3	(The council voted.)
4	MR. LESAUNDRI HUNT: Any no?
5	Next is the review and approval of July tribal
6	council minutes and actions. Can we get a motion, please?
7	MR. WILLIAM MAIDEN: Mr. Speaker, I'd like to
8	make a motion that we receive the July council
9	minutes and actions.
10	MR. JONATHAN LOCKLEAR: Second.
11	MR. LESAUNDRI HUNT: We have a motion and a
12	second. Okay. All in favor, say aye.
13	(The council voted.)
14	MR. LESAUNDRI HUNT: Any no? Thank you,
15	councilmen and council ladies.
16	First on our agenda is recognition of our election
17	board member, Mr. Crowley Locklear and I'm not going to
18	say a whole lot on that because the chairperson, Ms.
19	Sheila Beck, the head of the election board, is going to
20	come and present him a plaque, and we'd like to ask the
21	council members that's in those districts District 5,
22	7, and 11. Council members, if you would like to, come up
23	and join her.
24	MS. SHEILA BECK: Well, it sure is good to be on
25	this side of the ground this afternoon, and we serve

1	a merciful God, and we're thankful for Mr. Crowley.
2	Mr. Crowley's probably the epitome of those words
3	that we serve a merciful God and he has spread
4	that kind of love toward us on the election board,
5	and we would like to just recognize him tonight. And
6	this plaque says:
7	Crowley Locklear, presented on August
8	20, 2015, in appreciation for your six
9	years of hard work and dedication on the
10	election board for the Lumbee Tribe of
11	North Carolina.
12	MS. SHEILA BECK: Y'all listen to that. Six
13	years of service, six years. Thank you, Mr. Crowley.
14	(Applause.)
15	MR. LESAUNDRI HUNT: Can we get a portrait of
16	all the election board?
17	MS. SHEILA BECK: Election board? Mr.
18	Lesaundri, the speaker, would like for you to come
19	up.
20	MR. LESAUNDRI HUNT: We want to get a portrait
21	of all the election board.
22	(Applause.)
23	MR. LESAUNDRI HUNT: We want to thank Mr.
24	Crowley for six years of service on the election
25	board. It's a very hard-working board, so he

1	deserves special recognition.
2	Okay. We will give Ms. Anita a moment.
3	(Pause.)
4	MR. LESAUNDRI HUNT: Okay. We had no one sign
5	up for community comments, so the next thing on our
6	agenda is committee reports. Our ethics committee
7	the only one on our is our ethics committee. Ms.
8	Areatha Patterson?
9	(A discussion was held off the record.)
10	MR. LESAUNDRI HUNT: I have a request to go into
11	closed session.
12	MS. ANITA HAMMONDS BLANKS: Is there a reason?
13	MR. LESAUNDRI HUNT: Can we have a second?
14	MR. JONATHAN LOCKLEAR: Second.
15	MR. LESAUNDRI HUNT: Okay. We're going to have
16	a closed session. Ms. Areatha said for about ten
17	minutes. If you would, please, give us about ten
18	minutes.
19	(A discussion was held off the record in a
20	closed session.)
21	(On the record at 6:52 p.m.)
22	MR. LESAUNDRI HUNT: Okay. We need a motion to
23	come from a closed second.
24	MR. ALTON LOCKLEAR: Second.
25	MR. WILLIAM MAIDEN: I make a motion that we

1	come from closed session.
2	MR. LESAUNDRI HUNT: A motion has been made my
3	Mr. William Maiden and a second by Mr. Alton
4	Locklear. Ms. Areatha is the chairperson of the
5	ethics committee. Do you have any further
6	information?
7	MS. AREATHA PATTERSON: (Nonverbal response.)
8	MR. LESAUNDRI HUNT: Okay. We're ready to vote.
9	MS. JAN LOWERY: The motion?

21	over, and I looked at the minutes, and you allowed
22	him to vote on the sanction before, so I this is a
23	subject from before,
24	MR. LESAUNDRI HUNT: I think we

MS. ANITA HAMMONDS BLANKS: Mr. Speaker, the

1	board is addressing a conflict of interest. He
2	cannot vote. We've been over this 50 times before.
3	The laws say he cannot vote.
4	MR. LESAUNDRI HUNT: I think that question was
5	asked before why was he allowed to vote at that time,
б	and it was a decision that, that was on oversight if
7	my memory serves me correctly. Okay.
8	MS. JAN LOWERY: Doug Locklear?
9	MR. DOUGLAS LOCKLEAR: Yes.
10	MS. JAN LOWERY: Robert Chavis?
11	MR. ROBERT CHAVIS: No.
12	MS. JAN LOWERY: Jan Lowery, yes. Bill
13	Brewington?

8	MS. JAN LOWERY: I have 11, yes and ten, no.
9	Wait a minute. So it's ten to ten.
10	MR. BILL BREWINGTON: Motion ties.
11	MR. LESAUNDRI HUNT: We have a tie. The motion
12	was denied, it did not carry.
13	Next on our agenda is our tribal administrator's
14	report. Do we have an administrator's report? Mr. Alton?
15	MR. ALTON LOCKLEAR: We haven't heard a report
16	from economic development in quite some time. I want
17	to ask the chairperson if you could schedule a
18	meeting maybe next week or
19	MR. TERRY HUNT: Let me let me Mr.
20	Speaker?
21	MR. LESAUNDRI HUNT: Mr. Alton Locklear [sic]?
22	MR. TERRY HUNT: I've talked with the economic
23	board and stuff, and I think we're talking about the
24	26th. To my knowledge, that's what we're talking
25	about the 26th when everybody else will be here.

1	MR. LESAUNDRI HUNT: Okay. Mr. Jarrod, excuse
2	me I know your the head of the and you can do
3	it at another time the sales committee for the
4	T-shirts. Would you like to speak to that?
5	MR. JARROD LOWERY: Mr. Speaker, thank you. I
6	actually met with the education committee for the
7	meeting this month. I had that information. We need
8	a number?
9	MR. LESAUNDRI HUNT: Yes.
10	MR. JARROD LOWERY: About 60 or 70. But I'll
11	have the exact number at our next committee meeting.
12	MR. LESAUNDRI HUNT: Okay. Thank you. And
13	excuse me for putting you on the spot.
14	Next on the agenda is the calendar review.
15	MR. WILLIAM MAIDEN: Mr. Speaker?
16	MR. LESAUNDRI HUNT: Mr. Maiden?
17	MR. WILLIAM MAIDEN: May I ask a question,
18	please?
19	MR. LESAUNDRI HUNT: What's that?
20	MR. WILLIAM MAIDEN: In our minutes from the
21	last meeting, we approved in those minutes Ms.
22	Blanks made a request to the tribal administrator.
23	The council requested the names of those receiving
24	the 32 mobile homes when the ordinance was cleared
25	and the amounts we would be spending. Also, we asked

1	the administration for a updated mobile home list and
2	information on the land exchange, and I don't know if
3	anyone can give us an update on that.
4	MR. LESAUNDRI HUNT: Okay. Is anyone from
5	housing, administration want to speak to that? Can
6	we answer that question for Mr. Maiden?
7	MR. BOSCO LOCKLEAR: What was the question?
8	MR. WILLIAM MAIDEN: Mr. Bosco, in our minutes
9	from the last meeting, it was stated that the council
10	is requesting a list of names of those who will be
11	receiving the 32 mobile homes when the ordinance is
12	cleared. The council is asking the administration
13	for a updated waiting list and information on the
14	land exchange.
15	MR. BOSCO LOCKLEAR: We can get you a updated
16	waiting list. You want to know the mobile home list?
17	MR. WILLIAM MAIDEN: Yes. That's what we're
18	requesting.
19	MR. BOSCO LOCKLEAR: Okay. That's not a
20	problem. We can put that out tomorrow. The list for
21	those that's going to receive services you will
22	receive that list as you always do, when the services
23	and contracts have been done. We don't provide a
24	list prior to contracts. We've never did that, and
25	we're not going to do it now. Now the land an

1 update on the land. What were you wanting to see as 2 far as that goes?

MS. ANITA HAMMONDS BLANKS: We have been given information that you all are receiving a land swap -- those 100 acres that the tribe owned that had been -- there was a -- that was going to the owner -- the land that was being purchased in Candy Park. Except when we were given the appraisal, it had the total lot -- I think it was 88-something acres -- but we've been told that because the money apparently didn't add up to what they wanted it to, that now we're giving up about that whole parcel because we're being cut out; is that correct?

MR. BOSCO LOCKLEAR: The one we got was the land appraised for \$11,900 and something, and the amount of money that the land appraisal for Raynham -- we took the appraisal for Raynham and subtract it from the appraisal of this property -- from the whole 88 acres that was appraised. Then you subtract the 704 that you approved, then, there was like 96,000 short. So then the 96,000 divided by whatever the appraised was and whatever came out to be, seven point some acres -- that's the amount we didn't get. That's correct.

MS. ANITA HAMMONDS BLANKS: So has that taken

1 place already?

2	MR. BOSCO LOCKLEAR: Yes. The land swap and the
3	purchase has been completed. There was there was
4	if you go to that property and go to the other end
5	of that property, which I think is the Jaycee Hut
6	Road, there's 100 foot of that property that was put
7	into the purchase, and then from that 100 foot back
8	to the Deep Branch side of that property, then it
9	comes up it came up about 400 foot. That's what
10	amounted to the seven point some acres that we didn't
11	get which all of it's wooded land, so we didn't
12	lose. We purchased all the road frontage, though.
13	The seven acres and something we didn't get was at
14	the other end of the property, and it was woodland,
15	which all of that whole end across that property is
16	woodland.
17	MS. ANITA HAMMONDS BLANKS: Well, you know, I

MS. ANITA HAMMONDS BLANKS: Well, you know, I voted against that to start with,--

MR. BOSCO LOCKLEAR: Correct.

MS. ANITA HAMMONDS BLANKS: -- but it's my understanding that this council actually, those that voted for it, voted to approve the whole lot, so help me out here. Couldn't y'all do what was necessary to at least keep us informed?

MR. BOSCO LOCKLEAR: Well, I can tell you what

1	you voted on. If you look at the minutes, you'll see
2	what you voted on. If you look at the motion, what
3	you voted on you did a budget amendment.
4	MS. ANITA HAMMONDS BLANKS: Right.
5	MR. BOSCO LOCKLEAR: You approved the budget
6	amendment. The motion never stated how many acres it
7	was going to be for that and you voted for a
8	budget amendment, and that's what you did, so that's
9	what we did.
LO	MS. ANITA HAMMONDS BLANKS: The amendment was
11	based on the appraisal that was put before the
L2	council that night to include 88 acres. You know,
13	that sounds like some backdoor deals going on. I
L 4	mean, you all could have put that before this
15	council.
L6	MR. LESAUNDRI HUNT: Okay. Anyone else?
L7	MR. BOBBY OXENDINE: Mr. Speaker, is it possible
L8	to get the appraised value for the land for 100
L9	MR. BOSCO LOCKLEAR: For Raynham? Mr. Bill, you
20	may remember I think it was like 28 or 3,200. I
21	think it was somewhere around 20
22	MR. BILL BREWINGTON: It was 30-something
23	MR. BOSCO LOCKLEAR: It was 30-something, but
24	I'm forgot.

MR. BILL BREWINGTON: I believe it was 3,700.

1	May not have been now.
2	MR. BOSCO LOCKLEAR: No. It weren't 37. I'll
3	shoot an e-mail out to everyone tomorrow with that
4	price.
5	MR. BOBBY OXENDINE: Mr. Bosco, how many acres
6	was that?
7	MR. BOSCO LOCKLEAR: In Raynham? It's 100
8	acres.
9	MR. BOBBY OXENDINE: Thank you.
10	MR. BOSCO LOCKLEAR: I'll shoot an e-mail
11	tomorrow with an appraised value on both tracts.
12	MR. LESAUNDRI HUNT: And that's the same one
13	that we got before; is that correct?
14	MR. BOSCO LOCKLEAR: That's correct.
15	MR. LESAUNDRI HUNT: Okay. All right. Thank
16	you.
17	MR. BOSCO LOCKLEAR: And we'll send out through
18	e-mails probably some time tomorrow an updated
19	waiting list.
20	MR. LESAUNDRI HUNT: Okay. By way of
21	information to the council, the court case involved
22	in the ethics ordinance has been dismissed. The
23	Chairman withdrew that case. I have a letter in my
24	hand. That court case has been dismissed.
25	If we go to the calender please, Ms that hearing

on the 25th can be crossed out. On the 25th, though, there is the court case of the Chairman and the election board. The Chairman's requesting to be able to run again in the election. So that's in the newspaper, that's not brand new news or anything. That's in the newspaper.

And before we do go any further, yesterday, it was mentioned in the newspaper -- I thank Mr. Bobby for that article about the young man receiving a wheel chair. I don't know if he wrote that, but anyway. There was a article in there about a man at the college -- that's going to college that needed a wheel chair, and the vocational rehab did the paperwork and was hoping to get him a new wheel chair, a motorized wheel chair to get him to his classes. Before that, his uncle had died, and his friends were pushing him from class to class. Mr. Robert, if you have something you want to share with us.

MR. ROBERT CHAVIS: I'd like to comment on that. I had the opportunity to meet that young man, and to see people get something -- a little something like a bicycle or things like that. That child was so happy and appreciative. Now he loved that wheel chair, and he was thankful for that wheel chair. And I got a meeting with Celeste -- when they was carrying him home, and I tell you one thing, we need to strive to do more things like that. That is an excellent

1	program, and she just does a lot with that situation.
2	So I can tell you one thing, if you don't know what's
3	going on there if you have time, just walk in and
4	let her go through there and explain situations to
5	you. Thank you.
6	MR. LESAUNDRI HUNT: Okay. Back to the
7	calender. Any committees would like to set a date
8	for their meeting?
9	MS. JANIE MCFARLAND: Mr. Speaker?
10	MR. LESAUNDRI HUNT: Ms. Janie?
11	MS. JANIE MCFARLAND: I'd like to schedule a
12	finance meeting on the 1st at 6:30.
13	MR. LESAUNDRI HUNT: Finance meeting on the 1st
14	at 6:30. Okay. Anyone else?
15	MR. BOBBY OXENDINE: Mr. Speaker, education on
16	the 3rd, 6:30.
17	MR. LESAUNDRI HUNT: Education on the 3rd at
18	6:30.
19	MS. ANITA HAMMONDS BLANKS: Mr. Speaker?
20	MR. LESAUNDRI HUNT: Ms. Anita?
21	MS. ANITA HAMMONDS BLANKS: Can we set a
22	constitution meeting at 7:30?
23	MR. LESAUNDRI HUNT: Okay. That finish your
24	schedule, Mr. Bobby?
25	MR. BOBBY OXENDINE: Yes, sir.

1	MR. LESAUNDRI HUNT: Constitution at 7:30.
2	MR. TERRY HUNT: Mr. Speaker, when you get
3	through, I'd like to ask the council a question. I
4	was talking about having a meeting on the 26th. I'm
5	just now seeing that's
6	MR. ROBERT CHAVIS: We can't hear you. Speak
7	into your mic.
8	MR. TERRY HUNT: I was going to schedule
9	economic development on the 26th of August. That's
10	on a Wednesday night. We will be coming from
11	Virginia that day, and we'll do whatever the council
12	wants.
13	MR. LESAUNDRI HUNT: Okay. I just say find
14	another date, Mr. Terry.
15	MR. TERRY HUNT: Yes. Okay. I'll do that.
16	Just so the council knows.
17	MR. LESAUNDRI HUNT: Thank you. Is there anyone
18	else? Okay. If anyone wants to put anything on the
19	agenda. Mr. Bill wants to make a comment.
20	MR. BILL BREWINGTON: Yeah. I just want to make
21	a comment that when we had the grand opening for the
22	housing, and folks came up to me and make me promise
23	that I'd come see their new home. Folks, I know
24	and I'm not naming names or giving advice, but we
25	went and I appreciate it. I don't know how many was

1	there, but it's these three people that was calling
2	me, and it's almost like a new beach house or
3	something they're just so excited. So y'all that
4	can, let's go visit because I promised them I would.
5	We need to pass that on. I did get three positive
6	phone calls, so we are doing some good things. We
7	just need some good PR, and let people tell people
8	what we're doing. It will cover some of those
9	negative things. If you get a chance, let's go visit
10	those houses. That's it, Mr. Speaker.
11	MS. ANITA HAMMONDS BLANKS: Mr. Speaker?
12	MR. LESAUNDRI HUNT: Ms. Anita?
13	MS. ANITA HAMMONDS BLANKS: I would like to
14	announce that the District 9, which is Saddletree,
15	has their 15th annual pow wow, which is September 4th
16	and 5th out in Saddletree on Mount Olive Church Road
17	at Saddletree Community Center, and we'd love to have
18	everybody come and participate.
19	MR. LESAUNDRI HUNT: Okay. Mr. Jarrod?
20	MR. JARROD LOWERY: Mr. Speaker, thank you. And
21	thank you, Ms. Anita, for bringing that up. I want
22	to also say that we are also, some members of the
23	community, are also going to have a stick ball
24	competition, and we invite you all to come and invite
25	people to come. Stick ball is traditional to

1	southeastern culture, and we want to see all the
2	members, and we want you to play with the youth.
3	This is what we're doing, so it would be great if
4	y'all could join us.
5	MR. LESAUNDRI HUNT: Okay.
6	MR. BOBBY OXENDINE: Mr. Speaker, I'd like to
7	meet for just a few minutes with the council from
8	Districts 5, 7, and 11 immediately after the
9	meeting's adjourned.
10	MR. LESAUNDRI HUNT: And I'd like to have a
11	quick meeting with members from District 3, 2, and 14
12	immediately after also. I would entertain a motion
13	to adjourn.
14	MR. BILL BREWINGTON: I make a motion.
15	MR. JONATHAN LOCKLEAR: Second.
16	MR. LESAUNDRI HUNT: We got a motion and a
17	second. Would you stand and adjourn in prayer. Mr.
18	Homer Fields, would you lead us in prayer.
