# Lumbee Tribe 2024-25 Accomplishments

### \$27 MIL

Managed 463 mortgage accounts totaling \$27 million. Lumbee families are paying off at 1% & 2%

### \$2.7 MIL

175 families received Home Rehabilitation, which included 8 home replacements. \$842,500 in Downpayment Assistance to 61 families. Rental or mortgage assistance to 3 families totaling \$7,609.24


### \$1 MIL

The Energy Department assisted more than 3,200 households through the Crisis Intervention Program, and LIHEAP Programs.

### \$2.46 MIL

The Health and Human Services Department received more than \$2 million in grant funding since its establishment in 2024
