WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Council of The Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of The Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina has an Education, Cultural, and Public Relations Committee; and,

WHEREAS, The Education, Cultural, and Public Relations Committee established The Lumbee Educational Scholarship to assist tribal members through scholarships in their efforts to assist in the finances of their Education; and,

WHEREAS, The amount of \$157,410.44 is the budget for The Education, Culture, and Public Relations Committee; and,

WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina supports and agrees that the education budget in the amount of \$157,410.44 be spent as stated below; and,

THEREFORE, Be it resolved, The Tribal Council of The Lumbee Tribe of North Carolina supports and agrees that the designated funds be spent as described for scholarships and other educational and necessary purposes.

Kernice Lee Locklear Scholarship @\$3000.00 each for the three top high school graduates and for the three top college students, totaling \$18,000.00,

\$85,210.44 for scholarships in the amount of \$1000.00 each for high school graduates and college students,

Scholarship banquet - \$2000.00 Writing contest - \$600.00 Art contest - \$600.00 Writing scholarship essay seminar - \$1000.00 Endowment - \$50,000.00

\*Depending upon the number of students who meet the criteria and are recipients of a scholarship, monies may need to be transferred from the endowment fund of \$50,000.00 to meet the needs and justifications of all recipients.
