WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council implements a Health Committee to oversee the health and well-being of the Lumbee people, and to address all health disparities of tribal members, and;

WHEREAS, The Lumbee Tribe of North Carolina offers this resolution of support of a research study through The Duke Clergy Health Initiative and Duke Divinity School titled "To Heal the Wounded Soul," and;

WHEREAS, The Duke Clergy Health Initiative and Duke Divinity School will launch the program for pastors serving during cross currents of diseases, death disruptions, debt, and depression individually and in the community, and;

WHEREAS, The research study program is designed for pastors of the Wesleyan Native clergy or the United Methodist and Holiness Methodist clergy of African American, Hispanic, Latino, Asian, and Native American race and ethnicity to improve positive mental health and strong ministry through serving as pastors during the COVID 19 pandemic, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the research study project through The Duke Clergy Health Initiative and Duke Divinity School titled "To Heal the Wounded Soul" as a means to improve the mental health of clergy and to assist those pastors in creating strong ministry.
