"RESOLUTION TO TRANSFER \$4,000.00 FOR FOUR \$1,000.00 SCHOLARSHIPS"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of The Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina has an Education, Cultural, and Public Relations Committee; and,

WHEREAS, The Education, Cultural, and Public Relations Committee established The Lumbee Educational Scholarship to assist tribal members through scholarships in their efforts to assist in the finances of their education; and,

WHEREAS, Fifty high school students were allotted to receive a \$1,000.00 scholarship; and,

WHEREAS, An excess of four more qualified high school students met the scholarship criteria; and,


WHEREAS, Less than fifty allotted college students received a scholarship; and,

WHEREAS, A request is made to transfer \$4,000.00 from the allotted college section to provide a \$1,000.00 scholarship to each of the four qualified high school students; and,


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina supports and agrees to transfer \$4,000.00 to provide a \$1,000.00 scholarship each to four qualified high school students.
