DESIGNATION OF TRIBAL DISTRICT FOR PURPOSE OF TRIBAL VOTING IF LIVING OUTSIDE THE LUMBEE TERRITORY

You are entitled to vote in the Tribal elections, if you are Tribal enrolled member eighteen years and older living outside the Tribal Territory (Robeson, Scotland, Hoke, and Cumberland Counties, NC). However, you must declare a voting district for purpose of tribal voting. The district you select is a permanent designation and should include the community where you or your ancestors grew up, or the community you consider “home” inside the Lumbee territory.
