Chairman's Report

The chairman gave report on BIA updates. Mrs. Tammy Maynor will be the lead for Federal Recognition Transition. Ms. Heather Nakai will work along with Tammy Maynor as the Recognition Coordinator. Ms. Heather will be leading the initiative to prioritize the tribes efforts to ensure all potential programs and opportunities are identified. We will be focusing on exercising our sovereign rights and protecting the future of our tribe. Our nation building phase we need to address the tribes sovereign immunity and how it can and will be used to protect our long term viability. Ordinances will be brought to the Council regarding sovereign immunity. The BIA reviewed Constitution and our latest Enrollment Ordinances, this was the first step towards reviewing our process and procedures and verifying our rolls. The Enrollment Office is scheduled to speak with the BIA to dig and dive deeper into our enrollment processes. The tribe's Agriculture is to start working with the United States Department of Agriculture to identify programs we are eligible to apply for. The tribe is also looking into steps needed for us to have an extension program. With an extension program the tribe can collaborate with NC State University helping our farmers and ranchers. Funds have been identified to help assist our tribal historic preservation officer with consultations; organizations have already reached out to him. The chairman spoke on receiving remains and where we would be burring those remains, will that be secret or will that be public. Also equipment and storage will be need to preserve such artifacts. Tribal Consultations will be attended at the Federal Level such as VR, Department of Education and Indian Health Services. The Catawba Nation received a grant to establish a produce market for its tribal members. In collaboration with the Catawba Nation's Department of Agriculture, the Lumbee Tribe Department of Agriculture and Natural Resources has worked to create an opportunity to produce grown by Lumbee Farmers to be purchased and supplied to these markets. This initiative will take place next month (February), the Lumbee grown produced grown by our farmers will be purchased and shipped to the Catawba Nation. This collaboration strengthens our relationship with the Catawba Nation. Enrollment phases for updates will begin in the following weeks. Jan. 20 – Jan. 30, 2026 55 and older and out of territory. The next phase for enrollment updating will be in the weeks to come due to only three employees in that department. A discussion for new enrollee's maybe children up to 18 years of age phase.
