WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina hereby give permission to proceed with a Title VI Loan, not to exceed \$12 Million for the construction of E-36 located on Dunn Road, Lumberton NC to provide rental housing for the elderly;

THEREFORE, Be it resolved the Tribal Council of the Lumbee Tribe of North Carolina does hereby give permission to proceed with a Title VI Loan, not to exceed \$12 Million.
