"COMPENSATION FOR TRIBAL CHAIRPERSON"

WHEREAS, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ('Tribal Council') and;

WHEREAS, Article VII of the Tribal Constitution delegates the Tribal Chairperson holds the executive authority of the Lumbee Tribe of North Carolina, and;

WHEREAS, The Lumbee Tribe Tribal Chairperson responsible for all executive power including but not limited to representing the Lumbee Tribe of North Carolina before all other governments and tribunals, implementation and compliance of the annual budget, the execution of the policies, ordinances, and resolutions passed by the Tribal Council, as well as the administration of tribal programs and services; and

WHEREAS, The Lumbee Tribe is committed to fair compensation for its leadership to attract and retain qualified individuals who are dedicated to the advancement of the Tribe and its members; and

WHEREAS, The compensation for the Tribal Chairperson should reflect the duties, responsibilities, and time commitment required to effectively serve in this capacity; and

WHEREAS, The Tribal Council has reviewed comparable compensation for similar leadership positions within other tribal governments and determined that fair compensation for the Tribal Chairperson is essential to ensure effective governance and leadership; and

WHEREAS, The Tribal Council has also considered the financial position and available resources of the Lumbee Tribe in determining the appropriate compensation level, and has the authority to accept, appropriate, and enact all budgets, funding and allocation; and,

WHEREAS, That the Lumbee Tribal Council hereby establishes the annual compensation for the Tribal Chairperson at one hundred and thirty thousand dollars (\$130,000) with forty five thousand dollars (\$45,000) for benefits totaling in the amount of one hundred and seventy five thousand dollars (\$175,000), to be effective the 1st day of January 2025; and

THEREFORE, Be it enacted, that the funds for compensation of the Chairperson of the Lumbee Tribe of North Carolina shall be disbursed annually from the Lumbee Tribal Holdings (LTH) to the Lumbee Tribe of North Carolina, as permitted by available funds. This disbursement shall not impact the thirty percent (30%) allocation designated for member benefits, which shall be allocated first and prior to any allocation for the Chairperson's compensation.
