## “VAWA (VIOLENCE AGAINST WOMEN ACT) GRANT BUDGET”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget upon the Chairman's recommendation as deemed appropriate to maintain a balanced budget; and

**WHEREAS**, The Lumbee Tribe of North Carolina has received a grant from the North Carolina Department of Public Safety via North Carolina Governor's Crime Commission to be named “VAWA (VIOLENCE AGAINST WOMEN ACT) GRANT BUDGET” in the amount of \$198,196.31; and

**WHEREAS**, The grant will be administered as described in the budget below; and


**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “VAWA (Violence Against Women Act) Grant Budget” subject to all inclusions and provisions as stated by the North Carolina Department of Public Safety and Governor's Crime Commission.

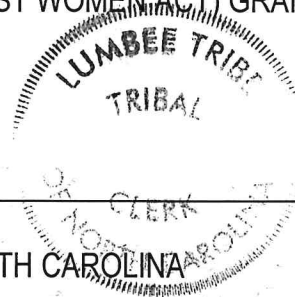



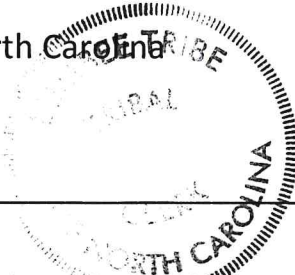
